When your documents are received and approved, International Student Services will send you a completed Form I-20 or DS-2019. You will take the Form I-20 or DS-2019 AND your second official copy of the supporting documents to the American Embassy or Consulate to apply for your student visa. Canadian students do not need a student visa.
