**I understand that it is my legal responsibility to comply with the rules and responsibilities of my F-1 or J-1 student status. I also understand that Gallaudet University is required by federal law to inform SEVIS regarding whether or not I report to ISSS.**

**I understand that I cannot travel to the U.S. **after** the start of the fall 2020 semester if Gallaudet makes an announcement that students can come to campus.**
